


至尊迷你倉租用服務禮遇 Rental services privilege at One Storage

條款及細則:

- 1. 此禮遇只適用於 3SUPREME 現有客戶,不得轉讓或轉售。
- 2. 此禮遇有效期由 2025 年 7 月 1 日起至 2025 年 12 月 31 日。
- 3. 此禮遇適用於至尊迷你倉現有客戶或新客戶。
- 4. 客戶簽約時須出示 3SUPREME App 內的 e-ID,方可享此禮遇。
- 5. 客戶須簽訂並預繳至少 六 個月至尊迷你倉合約費用,方可享此禮遇。
- 6. 客戶須於合約確認前登記使用優惠碼「3SUOS」,以享\$500 折扣。
- 7. 客戶須於合約確認前向至尊迷你倉人員申請並核實優惠碼,逾期無效。

 - 逾期作廢。任何遺失、損毀或逾期的現金禮券,恕不退款、更換或補發。






- **16**. 現金禮券可轉讓或贈送他人使用,但不可兌換現金、現金券、積分或其他產品和服務。

- 4. Customers must present their e-ID on the 3SUPREME App at the time of signing the contract to enjoy this privilege.
- 5. Customers must sign and prepay for at least six months of One Storage contract fees to enjoy this privilege.
- 6. Customers must register and use the promo code "3SUOS" before contract confirmation to enjoy a \$500 discount.
- 7. The promo code must be applied for and verified by One Storage's staff before contract confirmation; late requests will not be accepted.
- 8. The promo code must be used during the contract signing process.

 - Existing Customers: 120 days
 - Expired vouchers will be invalid. Lost, damaged, or expired vouchers will not be refunded, replaced, or reissued.
- 15. The Cash Voucher can be transferred or gifted to others but cannot be exchanged for cash, cash coupons, points, or other products and services.
- 16. Each Cash Voucher can only be used once. Photocopies or screenshots are not valid. Any voucher that is altered, torn, or damaged will be considered invalid.
- 17. The Cash Voucher cannot be used in conjunction with other vouchers.
