

免費蘇黎世 24 個月旅遊保險 條款及細則

Terms and Conditions for Free Zurich 24-Month Travel Insurance

1. 成功登記及兌換後，客戶將收到由 3Protect 發出的旅遊保險生效訊息，包括一個獨立參考編號作索償參考資料。 Upon registration & redemption, an insurance activation SMS/Email with a unique reference number will be delivered by 3Protect to your mobile number for claim reference.
2. 旅遊保險是由和記電訊 (香港)保險有限公司 (“和記電訊香港保險”) 安排，並由蘇黎世保險有限公司 (一間於瑞士註冊成立之有限公司) (“蘇黎世”) 承保。 Travel Insurance is arranged by Hutchison Telecom (HK) Insurance Limited (“HTHKIL”) and underwritten by Zurich Insurance Company Ltd, a company incorporated with limited liability in Switzerland (“Zurich”).
3. 旅遊保險只適用於由香港出發至保單所列明的受保地區。每次旅程之保障期最長以 45 日為上限，受有關條款及細則約束。 Only applicable to a journey from Hong Kong to covered destinations listed on the related insurance policy, with a maximum coverage period of 45 days per journey. Terms and conditions apply.
4. 兌換免費蘇黎世 24 個月旅遊保險計劃須是 3HK/3SUPREME 登記機主本人。每位持有有效香港身份證或有效護照 (身份證明文件) 的客戶，只可兌換一份旅遊保險計劃；無論購買多少份服務計劃。同一人士 (以身份證明文件識別) 重複或多次購買服務計劃，不會獲得額外或重複的旅遊保險保障。透過本優惠兌換的旅遊保險計劃不可轉讓，只限完成兌換的合資格客戶本人使用。 The redemption of the free Zurich 24-month Travel Insurance plan must be made by the registered account holder of 3HK/3SUPREME. Each customer holding a valid Hong Kong Identity Card (HKID) or a valid passport ("Identification Document") is eligible to redeem one travel insurance plan only, regardless of the number of service plans purchased. Duplicate or multiple purchases of the service plan by the same individual (as identified by the Identification Document) will not entitle the customer to additional or duplicate travel insurance coverage. The travel insurance plan redeemed under this offer is non-transferable and must be used solely by the eligible customer who completed the redemption.
